Camp Guidelines

Participation: For insurance and legal reasons, all campers staying overnight or on the grounds more than one day must be registered. All persons under the age of 18 must be registered with an adult who will be responsible for their decisions and well-being. All campers are expected to attend services, particularly those designed specifically for their age group. No one should be wandering the grounds during services.

Supervision: Because we are responsible for our teenagers and children, they are not permitted to leave the grounds without parental permission. Teens should inform their age-level director of any absences from activities. Teens must be housed with a responsible adult and may not visit with the opposite sex in a room or cottage without proper adult supervision. Parents should supervise their children at all times when not in age level programs.

Christian Conduct: Please be considerate of other campers in the use of TVs, radios, blue-tooth speakers, and other musical instruments. Entertainment should be acceptable for the Christian setting and at an appropriate noise level. Campers are asked to dress appropriately and modestly. Short shorts, short tops, see-through or skin tight clothes and suggestive or lewd printing are not becoming a Christian lifestyle. Obscene language, gossip and obnoxious behavior are also offensive and incompatible with the Christian lifestyle.

Health: Medical needs should be cared for as if you were at home. Contact 911 for emergencies, your local physician or health provider. First aid supplies are located in Thomas Hall kitchen and at the rear of the tabernacle.

Animals: Pets must be leashed at all times when outdoors and not left alone outdoors, walked on the perimeter of the camp grounds and picked up after. No pets are allowed in camp owned facilities. Proof of rabies shots is required to be on file with the office.

Prohibitions: The use of tobacco, alcohol or drugs is prohibited on the camp ground. No soliciting for funds or distribution of literature is permitted on the campgrounds without approval of the family camp director. Bicycles, skate boards and scooters must be registered and used only on the perimeter camp roads.

Property: Your personal property is your responsibility. We are not liable for any loss or damage. All camp property should be treated with respect and left as you found it. No candles are permitted in any camp owned buildings. Report any needed repairs to the caretaker.
